Pre-enrolment / enrolment / registration new students

Pre-registration (0-3 years old)

Parents make an appointment for an introductory meeting. If parents decide to give preference to our school after the meeting, they can show their interest by completing the pre-registration form.

The parents receive a confirmation of the pre-registration as soon as possible. We follow the 'order of entry' principle in the entire process, and therefore can quickly revert regarding the future placement.

Registration

If the child is 3 years old, parents will receive an official confirmation that the child has been permanently placed. If the child is placed on the waiting list, parents are kept informed of any changes. In both situations, the parents receive the request to confirm the registration. The registration is final after receipt of this confirmation.

Enrolment

The child is finally enrolled on his/her 4th birthday. Parents, whose child is on the waiting list, are kept informed of the developments.

Registration (3-4 years old)

Parents make an appointment for an introductory meeting. If parents decide to give preference to our school after the meeting, they can show their interest by completing and returning the pre-registration form.

The parents receive a confirmation of the official registration as soon as possible. If the child is placed on the waiting list, parents are kept informed of any changes.

Enrolment

The child is finally enrolled on his/her 4th birthday. Parents, whose child is on the waiting list, are kept informed of the developments.

Enrolment (4 years and older)

Parents contact the school to discuss the placement possibilities. If there are possibilities, an introductory meeting follows. If the parents want to enrol the child after the introductory meeting, they must first report this to the current (old) school. An exchange of information then takes place. If it turns out that we as a school can address well to the learning and educational needs, a definitive appointment is made for placement.

In the entire process, we use the principle of order of entry of the pre-registration form.
